FINAL EXECUTIVE PAPER: Pathway out of Restrictions – Proposals for Relaxation - Indoor/outdoor gatherings, household/bubbles, close contact services, licenced & unlicensed premises, live music/dancing

Introduction

 The purpose of this paper is to outline a number of proposals submitted for relaxation and to agree a position.

Background

- 2. In the Pathway out of Restrictions, the Executive outlined its priorities for relaxing restrictions. This included a focus on outdoor settings, and allowing families the opportunity to reunite. This group of relaxations builds on that focus, as well as having significant benefits for the music and events sector which have been unable to return since we initially locked down in March 2020.
- 3. Advice has also been sought from the Chief Medical Officer and Chief Scientific Adviser.
- 4. You will note that their advice raises concerns about making further relaxations at this point due a number of Delta variant related factors, i.e. the discovery of it within the community, the significant number of unknowns in relation to the efficacy of the vaccine in relation to it, and the relationship between cases number and hospitalisations.

5. In light of the Delta variant concerns and the timing of data availability, this paper proposes ratification at a time when more data will be available to allow the Executive to make fully informed decisions. Whilst it is not ideal to give indicative dates, subject to further decisions, it is required given the concerns around the variant and the need to fully ascertain the impact of previous relaxations.

Working from Home, Social Distancing and Face Covering decisions

- 6. There have been recent discussions on moves to the return to workplaces, the wearing of face coverings and the continued requirement for social distancing. You'll be aware that UKG are considering these issues under their stage four relaxations due to be announced on Monday 14 June.
- 7. We understand they are considering a number of options, ranging from maintaining the status quo to the removal of the requirements. They are also considering a number of interim options, such as application in certain settings only, e.g. allow some sectors to return to work, remove social distancing for outdoor events only, move face covering requirements into guidance only.
- 8. Officials across Government here are working through the options available here, however given the Delta variant resulting in the epidemiological picture changing rapidly, it is proposed that we delay any further exploration of these areas until we have more data available and allow our discussions to be informed by that data, as well as positions elsewhere.

Summary of Proposed Relaxations

- 9. From 21 June (subject to ratification on 17 June):
 - a) To permit indoor gatherings in a domestic setting of ten people from no more than two households. If one household has ten members, the maximum is increased to 15 from no more than two households.

- b) To permit outdoor gatherings in a domestic setting of 15 people from an unlimited number of households.
- c) Remove the linked households/bubble provision.
- d) To permit outdoor gatherings to the maximum allowed as per risk assessment for venue across all sectors. Over 30 people must be an organised gathering and would require a risk assessment.
- e) Enables close contact services to open without appointments but with remaining mitigations.
- f) In licenced and unlicenced premises which provide or sell food and drink (whether or not including intoxicating liquor) for consumption on the premises permit live music at background or ambient levels; the volume must be such to enable visitors to conduct conversation at normal loudness of speech.
- g) At outdoor events, permit live music and dancing, without restriction to background or ambient levels.
- h) Permit live music, without restriction to background or ambient levels for rehearsal, recording or performance purposes in concert venues, theatres and other indoor venues which, for the duration of the rehearsal, recording or performance are set aside for that purpose. No dancing for audience.
- i) Permit live music, without restriction to background or ambient levels for "other indoor venues" can include a space within larger premises for example a function room or conference suite within a hotel. In such circumstances access to the venue must be effectively controlled and managed and the venue must be sufficiently isolated from the rest of the premises to ensure that the volume of the music in the venue does not breach ambient or background levels in other parts of the premises. No dancing for audience.

Note - entry to performances for audiences will be by ticket only. Tickets must be purchased in advance of the performance. Audiences for indoor events must have allocated seating and remain seated.

 Enable social distancing at minimum 1 meter for live music related activity in indoor seated venues and at all outdoor events.

From 1 July 2021 (subject to ratification on 17 June)

k) A restart of overnight residentials for youth services as part of the continued phased reopening of youth services to facilitate delivery of the summer youth programme as part of the continued phased reopening of youth services, facilitate delivery of the summer youth programme.

From 22 July 2021 (subject to ratification on 15 July)

I) Remove any restrictions on live music and dancing in licenced and unlicenced premises which provide or sell food and drink (whether or not including intoxicating liquor) for consumption on the premises.

CMO/CSA Advice

General comment:

CMO/CSA have advised that they are very mindful of the current health service pressures and there is in their view little tolerance or capacity for significant increased COVID-19 admissions. If indeed admissions of the Delta variant are x 2.4 and vaccine effectiveness more dependent on second doses then the Executive will need to factor this in to the timing of decisions on any further relaxations which may be best deferred to middle to end of July.

Behavioural Science Advice

10. BiT and ILab colleagues have recommended an audit of existing guidance for organisations to ensure that it matches the most up to date understanding of how the virus spreads.

Response

11. Departments and government agencies are regularly asked to ensure that their sectoral guidance is up to date both in respect of the latest position for the regulations and most recent public heath advice.

Recommendation

12. It is recommended that the Executive agree:

- the proposed dates for the following relaxations (as below) with a ratification dates of 17 June and 15 July,
- and recommendations in relation to a safer travelling messaging, and the use of LFTs.

From 21 June (subject to ratification on 17 June):

- a) To permit indoor gatherings in a domestic setting of ten people from no more than two households. If one household has ten members, the maximum is increased to 15 from no more than two households. (Does not include children 12 and under).
- b) To permit outdoor gatherings in a domestic setting of 15 people from an unlimited number of households. (Does not include children 12 and under).
- c) Remove the linked households/bubble provision.
- d) To permit outdoor gatherings to the maximum allowed as per risk assessment for venue across all sectors. Over 30 people must be an organised gathering and would require a risk assessment.
- e) Enables close contact services to open without appointments but with remaining mitigations.
- f) In licenced and unlicenced premises which provide or sell food and drink (whether or not including intoxicating liquor) for consumption on the premises, permit live music at background or ambient levels; the volume must be such to enable visitors to conduct conversation at normal loudness of speech. No dancing.

- g) At outdoor events permit live music and dancing, without restriction to background or ambient levels.
- h) Permit live music, without restriction to background or ambient levels for rehearsal, recording or performance purposes in concert venues, theatres and other indoor venues which, for the duration of the rehearsal, recording or performance are set aside for that purpose. No dancing for audience but permitted as part of performance.
- i) Permit live music, without restriction to background or ambient levels for "other indoor venues" can include a space within larger premises for example a function room or conference suite within a hotel. In such circumstances access to the venue must be effectively controlled and managed and the venue must be sufficiently isolated from the rest of the premises to ensure that the volume of the music in the venue does not breach ambient or background levels in other parts of the premises. No dancing for audience but permitted as part of performance.

Note - entry to performances for audiences will be by ticket only. Tickets must be purchased in advance of the performance. Audiences for indoor events must have allocated seating and must remain seated (unless using facilities).

- j) Regulate for social distancing at minimum 1 meter for live music related activity in indoor seated venues and encourage social distancing in guidance for all outdoor events.
- k) EIS to prepare messaging around safer travel options.
- Return to decisions on the use of Lateral Flow Tests when the report from the learning events and pilots elsewhere are available.

From 1 July 2021 (subject to ratification on 17 June)

m) A restart of overnight residentials for youth services as part of the continued phased reopening of youth services to facilitate delivery of the summer youth programme as part of the continued phased reopening of youth services.

From 22 July 2021 (Subject to ratification on 15 July)

n) Remove any restrictions on live music and dancing in licenced and unlicenced premises which provide or sell food and drink (whether or not including intoxicating liquor) for consumption on the premises.
