Subject: Meeting on Operationalising new policy on testing for care home residents

Dear all

In light of the prevalence/transmission of Covid in care homes, the CMO has asked us to move to a policy of:

- Testing all individuals before admission to a care home
- Testing all symptomatic residents in a care home

This will be announced tomorrow as part of the social care action plan publication.

Hitherto, local PHE health protection teams have been undertaking some measure of testing in care homes. But it is clear that there is insufficient capacity to do this at the scale now asked, and we will need to develop a different operational model to deliver this new ask. I don't know realistically what that is, but I am copying you all as people who might be able to help generate ideas, and help us access eg. community health, CQC, the testing community...

NR – please can you set up a meeting this afternoon if possible of people on the copy list, or people they recommend...
