

You both were sighted on the read-out of yesterday's call between government officials from across UK governments to discuss the on-going position to the Coronavirus outbreak. From this we can ascertain that the first confirmed case of the virus in the UK is likely and that contingency planning is underway in the event of this. I have been invited to join a COBR call at 1630 today and will have the opportunity to raise our contingency planning on this call. However given the number of cross-cutting portfolio interests the outbreak of the virus is now affecting I would be grateful if you could consider standing up our SGoRR arrangements in order to co-ordinate our planning and preparation across areas of government.

I would welcome your thoughts on this as soon as practically possible.
