### Long ToR for internal use

The Taskforce will aim to:

- Make sure there is sufficient testing capacity to support the government's strategy to reopen economic and social activity in the coming months
- Integrate the test, track and trace programme and make sure it is successfully launched to the public.
- Agree a single vision to guide the implementation of testing and tracing policy across the Four Nations of the UK.
- Ensure that citizens' personal data are transparently managed in the programme.
- Agree incentives and a policy framework to drive compliance with the tracking and tracing programmes and the public health advice to citizens with symptoms and positive tests including any enforcement mechanisms required.
- Agree on an evidence-based policy framework for introducing personal risk assessments based on individuals' exposure to the virus and any immunity they may have acquired.

Devolved status:

- Health policy, including testing and contact tracing, is devolved.

The Taskforce will oversee the existing HMG governance structure for TTT. An approach to monitoring progress - including action-tracking and metrics - will be agreed in the first meeting of the Taskforce.
