Dear Jamie and James,

Following Monday's publication of the Homecare Guidance, and the PPE Task and Finish Group yesterday, there are three matters which I wish to bring to your urgent attention:

- 1. Suppliers offering masks which do not conform to the Government's published specification, because they do not have sufficient stocks of Type IIR surgical masks.
- 2. A disparity in the Homecare Guidance between reference to "Fluid-repellent surgical mask" in Table 1 and "Surgical mask" in Table 2.
- 3. The massive discrepancy between the requirements of PPE, and the available supply.

This e-mail makes four recommendations to PHE and DHSC, as follows:

- 1. PHE to provide guidance on whether any mask which falls below the specification of "BS EN 14683:2019" is suitable, and if so, what variation from the standard is still acceptable, if any.
- 2. PHE to provide urgent clarification on the disparity of wording in the Homecare guidance now, and address the matter in a revised version of the homecare guidance.
- 3. PHE to provide guidance on whether wearing home-made cloth masks is better than no masks at all.
- 4. Government continue to work on the supply chain to increase the supply of suitable PPE, along with approving any guidance issued by PHE in relation to item 1, above.
