26/03/20	PDI HC	Wipes manufacturer – stating they are at full capacity for NHS can't get stock until end of May
26/03/20	Elis – laundry	laundry / scrubs said they were at fully capacity for NHS
26/03/20	MIP	"The conversation with MIP was over the phone not on email and he used the words NHS have "ring-fenced all the stock"."
05/03/20	Deliver Net	The manufacturer re sanitisers it was the distributor (Deliver Net) who used the words NHS have "Commandeered the stock" so it could not be supplied
