Summary note of today's call with CDL

Planning for Christmas – CDL mentioned briefly, said officials working on options for alignment as far as possible.

Mass testing – contributions from Susan Hopkins (Public Health England lead on Liverpool mass testing pilot) and Shona Dunn (2nd Perm Sec leading on the wider rollout).

Susan Hopkins: evaluation of lateral flow tests is encouraging: sensitivity 70%, specificity 99%. By last Friday 50k tests delivered by the military in Liverpool. Positivity rates lower than expected, partly reflecting the declining incidence, now around 200 per 100k. Lots of learning on operational and behavioural aspects. Potential for 50% reduction in transmission by asymptomatic individuals. Challenges: how to incentivise participation and what are the implications of getting a negative test.

Shona Dunn: currently in discovery phase on the role of mass testing in the wider strategy and potential levers on participation.

FM: keen to achieve alignment on arrangements for Christmas, clear and simple as possible. Need to think also about the run up and aftermath to mitigate risks. Social freedoms more important to people than economic freedom in this period. Looks forward to returning to this discussion in light of officials' work. Congratulates those involved for the progress on lateral flow testing. Need to understand the interplay with mass vaccination. Potential benefits include: care home visiting, reducing school absence, potential to come out of self-isolation, participation in sporting or arts events.

Nicola Sturgeon: agree re developing an aligned approach to Christmas, careful decisions needed recognising risks and practical reality. She is very cautious on international travel. On lateral flow testing – need early clarity on volumes and timing. SG considering prioritisation options and how best to select locations for mass testing: cities, parts of cities or small towns. Need clarity that negative test is not a free pass.

Arlene Foster: echoed earlier points. Suggested mass testing worthwhile when incidence above 50 per 100k. Could be valuable in high risk workplaces such as meat factories.

Michelle O'Neill – clarity on NI share of tests, and freedom to determine rollout plan.

CDL confirmed there will be equitable distribution on Barnett basis, in relation to devices and logistical support. Will be for each government to determine how to prioritise. (Shona Dunn- numbers are still changing, working with officials.) Need a fair and visible process for rollout, sense of reciprocity with the citizen – participation in return for some freedom if test is negative. Need shared understanding of purpose and benefits.
