Subject: RE: Official sensitive: Ministerial call 10 September - update on announcements today

In yesterday's Ministerial call the First Minister said that urgent decisions would be needed during the day to respond to the deteriorating position in Wales (and the wider UK), and that Ministers would be updated.

To confirm that the decisions which will be announced by the FM in his press conference today, to come into effect on Monday, are as follows.

Meetings indoors

- we will introduce a limit of 6 people on numbers meeting indoors, and those 6 people must be from the 4 household bubble currently permitted
- there will be no change to the rules on meeting outdoors ie permitted for groups of up to 30
- exemption for a single household with more than 6 members
- this will apply in all indoor settings, including private homes and pubs etc
- children under 11 will be exempt.

Face coverings
