Covid-19 Response

THE PRIME MINISTER said that the data on Covid-19, particularly the new Omicron variant, was not encouraging. The doubling rate was high. There was much we did not yet know. There was some reason for guarded optimism: but any disease, however mild, that replicated that quickly and affected large numbers of people, would inevitably put pressure on the health system. This posed a significant problem. The answer must include keeping on with the vaccination booster programme, and jabs would be offered to all those over 18 years old by the end of January. But he would not be doing his job if he was not clear with Cabinet colleagues about the potential for numbers of infections to rise very fast. The Government should be encouraging people to be cautious and to manage risk as best they could.

THE SECRETARY OF STATE FOR HEALTH AND SOCIAL CARE said that the Omicron strain was much more infectious than Delta, with a faster doubling time. It was widespread throughout the UK and case rates could even peak later that month. It was not inevitable that the NHS would become overwhelmed, but that was how it looked on some projections. Vaccination remained critical, and the UK was providing jabs as fast as any country in the world. But it would be impossible to administer a booster to every person within the next two weeks. The NHS was now stepping up its contingency plans.

THE GOVERNMENT'S CHIEF MEDICAL OFFICER said that the Omicron variant was doubling roughly every three days, which would lead to big numbers very fast. It was not yet clear how severe the health effects on individuals would be, but it was clear from the modelling that they would have to be very substantially less severe than Delta to avoid unmanageable pressures on the NHS. The Government should consider acting now.

THE GOVERNMENT'S CHIEF SCIENTIFIC ADVISER said that Covid growth was exponential, while the degree of severity was linear. Any gains from lower severity would quickly be overtaken by rapid exponential growth. At this stage it was clear that vaccines were much less effective at preventing infection from the Omicron variant, but they would hopefully reduce the severity of infection and offer protection against hospitalisation and death.
