I have just asked chris to confirm a professional view - as i would expect it reads very well...

These are thoughts rather than requirements: just wonder if on last question whether we need to state that we will continue to identify and replenish supplies through existing and new NHS Wales supply contracts but we are working with UK government supply arrangements which will also be critical to access and maintain supplies in Wales / need this to be understood?.

And also to emphasise somewhere whether in last question or earlier that we always work to UK guidelines and advice and will adapt guidance and supply accordingly. (Not least point of guidance potentially changing).

At some point as these faqs develop ahead we will need to find a way to share where ppe isnt needed for other services or public (in order to protect supply and limit requests).

Hope that helps - i think chris may be just checking with Robin at PHW.
